WORKGROUP HOST NOTES – WORKGROUP SESSION DAY 3

Thank you for agreeing to be a workgroup host (or speaker!) at our conference. We have compiled these notes to help you understand how the workgroup sessions will run. - 1. There will be six workgroup themes running simultaneously throughout the day. While these will be parallel sessions, they are organised so that every participant can attend one of the workgroup sessions.
- 2. Each workgroup theme will have the same facilitator throughout and will be based in the same room for the day.
- 3. Each workgroup theme will have three rounds of 1hour 15 minutes each. The audience for each round will be different but we expect groups to be no more than 20 people.
- 4. Each round will commence with a presentation from one of our workgroup hosts. We expect content of between 15 and 20 minutes which does not have to be formally presented. Your facilitator might stop you after you make an important point to get comments from the rest of the participants. Feel free to take questions from the floor during your presentation. The purpose of the presentations is to provide stimulus (food for thought) for the discussion group. You can make the presentation last for the duration of the whole session if discussion is lively and fruitful!
- 5. Presentations will lead to open discussion led by the facilitator with contributions from the speakers and plenary speakers from Day 1. The point of these sessions is to be interactive with the audience.
- 6. At the end of each discussion the facilitator will summarise the main conclusions and highlight any recommendations these will be agreed by the participants in that session.
- 7. All the findings will be collected at the end of the day and presented as main recommendations to the whole group during the feedback in the final plenary session. The aim is to ratify the recommendations before submitting them to the EU policymakers.
- 8. IMPORTANT we will be holding a video briefing session via TEAMS before the event to introduce you to the other presenters in your workgroup, your facilitator and the Platform Coordinator. We will use this opportunity to explain a bit more about how the session will run. Please do respond to the Doodle Poll invitation which is circulated with this email.
